Once the trip is confirmed by TCLF, the deadlines, conditions and cancellation policy on this document must be fulfilled. If the conditions stated on this document are not followed, Around Art reserves the right to cancel the trip for the benefit of our clients, providers and company.

The price of the trip is based on the minimum number of 20 paying participants in double occupancy, to produce everything as outlined in the itinerary. If numbers fall over this minimum a different price will not be calculated. For example: 21 participants will have the price of minimum 20 participants.

CLIENT is responsible for publicizing this trip to those deemed appropriate by CLIENT and for recruiting a minimum number of participants as stated above in this document. In addition to stipulations concerning minimum participation as noted above, if CLIENT makes refund arrangements between itself and the trip participants other than stated in this contract, the costs of these arrangements are to be born totally by CLIENT.

If numbers fall below the minimum and if CLIENT decides to nevertheless proceed with the trip, will be responsible for meeting the budgeted costs and terms stipulated and will decide in collaboration with Around Art, what, if any, changes need to be made in the itinerary.

Notification of a minimum or more participants must be given to Around Art by 15 December 2023

Notification of the final number of participants must be given to Around Art by 1st April 2024

Around Art will make every effort to execute the itinerary as planned. Around Art reserves the right to make substitutions, as necessary, in consultation with CLIENT representative in case of cancellations or unforeseen problems, as they arise.

### **Cancellation policies above the minimum number of participants**

Any cancellations of participants will be made in writing and will have an administration fee of 300€. 45 days (25 April 2024) prior to departure from origin, loss of the deposit, unless he/she is substituted by another person.

Cancellations received after this date and up to 30 days (10 May 2024) prior to departure are subject to an administrative fee of 60% of total cost per person unless he/she is substituted by another person.

Cancellations received after this date and up to 16 days (26 May 2024) prior to departure are subject to an administrative fee of 90% of total cost per person unless he/she is substituted by another person.

Cancellations received within 15 days (25 May 2024) prior to departure are not subject to any reimbursement unless he/she is substituted by another person.
