i also wanted to forward on to you something i got from Mary's friend Nord about a 2012 agreement that someone else brought up to me (they said Mary signed off on demolition in 2012, so i asked her and Nord):
"Mike,
Thanks for your note. The 2012 letter referenced has been grossly mischaracterized and distorted by the Art Center's leaders. The two-page letter was about restoration of the artwork. There is a mention of removing the work in a discussion of fundraising; but the vast majority of the letter is about restoration.
It opens:
Dear Jeff,
I am glad I was able to come out to see the pond project and discuss how we might proceed. As I mentioned since it is one of the few large scale permanent public project I have and the only large outdoor work I have at a museum space (the Indy Art and Nature Park project has a limited installation period) I am particularly interested in seeing it restored. I do recognize the obstacles in doing this I would like to outline some thoughts I have had.
And it closes:

I hope this provides a road map for moving forward with the restoration work. I really appreciate your interest in having the work whole again and I am happy to work with you to explore possible solutions.

In addition, that letter in no way can be construed a change to the terms of the 1994 contract, which remains in place. The Art Center's Director and Board and legally and contractually obligated to the terms of the 1994 contract. Any suggestion that the terms have been voided, nullified, or otherwise altered is completely false. That's what our lawyers have said.

In terms of the 1994 contract, here are two important sections concerning the Art Center's legal obligations:

- 8.2 Alteration of the Work or of the Site.
  - Art Center agrees that it will not intentionally damage, alter, relocate, modify or change the work without the prior written approval of the Artist.
  - 2. Art Center shall notify the Artist of any proposed alteration of the Site that would affect the intended character and appearance of the Work and shall consult with the Artist in the planning and execution of any such alteration and shall make a reasonable effort to maintain the integrity of the Work.

The Art Center has not gotten the artist's written approval and they have not consulted "with the Artist in the planning and execution of any such alteration and shall make a reasonable effort to maintain the integrity of the Work." The consultation is a requirement not a suggestion.

What Art Center Director Baum and the Board of Trustees are planning to do is to breach that contract. Should that happen, then no one will ever be able to trust them; no donor, artist, other museum, supporter, etc. can ever trust that the current director and the current board members will honor any contract. They will have shredded their credibility. They have already broken their word to the artist and their trust with the public.

Mary has repeatedly ask questions and sought documents that would substantiate Ms. Baum and the Board's claims. And Mary has been repeatedly been ignored. Ms. Baum "open letter" of Feb. 3 speaks of transparency.

There is no transparency on the part of the Art Center's leaders. They've broken their word, grossly mischaracterized Mary's intent, and they want us to trust them?

This issue is not what other agreements exist, the issue is why won't Ms. Baum and the Board provide the answers and the documents Mary has requested? If they want Mary's written approval to destroy this work, why are they ignoring her? And if the Art Center claims they've engaged her, then they're not being forthright, rather they're being manipulative and distorting the truth.

You might also ask what efforts have been made to sell or gift the work to another institution. To our knowledge, that has not happened.

The board has been involved in discussions and decisions around Mary Miss' pieces since
October. That is when we were informed that the installation was declared dangerous and unsalvageable by a structural engineering firm. The piece is beloved and a major work of art for Des Moines and so many youth, families, and art lovers, so the safety of the community members was extremely important. There was extensive research and study, including input from engineering and construction experts, which led to the decision to dismantle the iconic piece.

I love the innovation of ideas that you share, but considering this piece is submerged in and around water with the foundation in wet mud, complicates many elements, including installation and materials, of this complex piece. I wish it was as simple as asking folks to show up to rebuild. I would be the first to jump on board.
