TERMS AND CONDITIONS:

The price of the trip is per person and is based on a **minimum of 15–20 paying participants** in double occupancy, as required to operate the itinerary under the stated conditions.

All registrations are individual, and payments are made directly by each participant to Around Art.

The final price is contingent upon reaching the minimum number of participants. **If the minimum is not reached, Around Art reserves the right to adjust the price per person accordingly or cancel the trip.**

Impact of Cancellations on Group Pricing

Participants are expressly informed that the cost of the trip is based on a group structure. Therefore, any cancellation that reduces the number of participants below the required minimum may result in a price increase for the remaining participants or, ultimately, in the cancellation of the trip.

By confirming their participation, each participant acknowledges and accepts this condition.

Minimum Confirmation Deadline

Confirmation that the minimum number of participants has been reached must be achieved no later than **6 months prior to departure.**

CANCELLATION CONDITIONS

Participants may cancel their booking at any time before departure. Around Art will always aim to minimize cancellation costs and will only pass on costs that have effectively been incurred and are non-recoverable.

Impact on Group Pricing: As the trip is based on a minimum number of participants, cancellations may affect the overall cost structure. If a cancellation reduces the group below the required minimum, **TCLF** will first attempt to find a replacement participant.

If no replacement is found, Around Art reserves the right to:

- adjust the price for the remaining participants, or
- in exceptional cases, request the cancelling participant to cover the resulting shortfall, always limited to the actual unrecoverable costs.

Cancellation Costs

Cancellation charges will consist of:

- 150€ of administration fee per participant

Any non-refundable costs already committed to suppliers (such as transport, accommodation, tickets, or special services contracted under strict conditions).

The exact amount will depend on the timing of the cancellation and the conditions imposed by each supplier.
